5. Treasurer's Report by Ranjan

The income is not coming in and pledges are not being met, therefor income is down. Deficit will be larger than originally projected. Insuring the West Street property, even if we do prove occupancy, is proving to be an issue because our current insurer does not want to provide a policy for the property that has been uninsured for a period of time. Our Agent will look for another insurer and get a quote for an occupied building and property. He will also contact UUA (Richard Nugent, church finances) to see if there is any way they can help us.

Motion that we go ahead with the special October meeting by Ranjan, seconded by Lisa.

The floor opened for discussion. We will provide the congregation with best financial numbers that we have, and the best information we have on the real estate markets. A question was raised if it would be important to have a full year of expenses by waiting until December to have the congregation vote. The point was made that December is a very busy meeting without adding this issue. The point was made that every month we delay may bring more information, but the decision still must be made. A lot of factors are subject to change and prices are subject to change, we can get bogged down in the details. Discussion was closed.

Vote: 4 in favor, 1 opposed, passes – motion passed, the meeting will proceed on 10/21.

It was decided that the options to be presented are as follows:
