## **Call to Order and Establishing Quorum**

The chalice was lit and the meeting was called to order at 12:30 p.m. 20 voting members were in attendance reaching quorum with the necessary 30% of voting members. Katie asked people to state their name and speak loudly.

Snowdancer explained the function of the monthly Ministry Council meetings with 17 members who are involved. Katie added that the building, grounds, garden project and well restoration falls under their purview. There is a vacancy for leadership for the teenage program.

# Highlights from Essential for LAY LED Congregation Workshop

The LAY LED workshop was 4 hours. Eric Wood reported our church is doing well in comparison to other churches.

Dave Morgan attended 2 workshops worship service and pastoral care and reported we are doing well on pastoral care

Adrienne Tinn reported on the 2 workshops she attended, leadership development and pastoral care.

# Minutes

The minutes were read for the Summer Congregational Meeting 2022, Sunday, June 5<sup>th</sup> by Katie Coates.

Jill Morgan motioned to approve. Eric Wood seconded. 12 approved and 1 abstention.

# GS4GND

Katie and Esther gave an explanation about the goal of Gulf South for the Green New Deal (GS4ND), which overall is comprised of Texas, Florida, Mississippi, Louisiana and Puerto Rico, to address social injustices in communities. They are asking us to sign on to their policy platform which had been sent to the church's members prior to the meeting. We are not obligated for any financial or work commitments. Due to the compatibility in values and beliefs coupled with the church's location, their funding gives the church an opportunity to be active as well as revitalizing the well water and establishing the garden.

Jill M expressed her concern about committing the church's resources or taking on projects that the church might not be able to support and asked if we are simply voting on aligning with GS4ND. Esther responded that there is nothing required of us, it provides resources for us. We are ready to compost and recycle plastics bottles.

Natali Maynor moved to approve and Beth Philip seconded to sign on to the GS4GND platform. All approved.

# **Financial Report and Approve Budget**

Treasurer, Lisa Dunn, provided copies of the financial report for attendees. Financial statements consisted of the balance sheet through October 2022 and the Schwab account as of June 30<sup>th</sup> because she hasn't received the most current statements. Highlighting the budget vs actual, as of October, there is a \$34,000 deficit which reduces the general fund balance. The building fund for renovations were increased by vote. The cost for utilities is \$15,000. Estimated income for next year is \$29.400. In the 2023 budget, there is also a deficit that will reduce the general fund balance. There is no budget for a minister.

Jill asked if we will adjust the budget down the line for a possible minister. The answer was a yes. Kristin Golden asked if ministers get paid. Ministers are unionized and are paid.

Kristin Golden asked who is doing the counseling since we don't have a minister. Snowdancer explained costs for ministerial care is \$135 an hour. Weddings/funerals are \$500 and up. Snowdancer will doing the rights of passage.

Eric suggested making a minimal payment until the water meter is fixed. Lisa said that we are paying \$200 for both buildings.

Ranjan asked if we are going to dig into general fund for the deficient? Yes, we will.

Jill Morgan motioned to approve as present by Lisa. Eric Wood seconded it. 17 approved with Bob Keller a nay.

## **Ministerial Search Survey Report Update**

Jill Morgan, Chair of the Minister Search Committee, thanked members for filling out the survey (roughly 20 people) and gave the results of the survey. What was most important to people for the role of the minister: pastoral care, Sunday service, and UU representation in leadership. The responses showed that some level of minister is needed, as an ambassador for the church and community outreach was important to people. We have a liberal church in a conservative state. One of our strengths is people volunteer and are willing to work. Snowdancer worked out an interim arrangement with Reverend Edith Love who will do one Sunday service a month for 2023.
